

## "Win a 0% APR Auto Loan" Sweepstakes

**Official Rules** 

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- 1. <u>Eligibility:</u> The "Win a 0% APR Auto Loan" Sweepstakes (the "Sweepstakes") is offered to all Unity One Credit Union members, new and existing, in good standing age 18 or older. Winner must be a member or eligible for membership in order to qualify for and obtain a loan. Indirect auto loans (i.e. loans made through 3<sup>rd</sup> parties or dealerships) are not eligible for sweepstakes. Members must have loan funded by date of drawing to be eligible. No purchase necessary to enter the Sweepstakes. Employees, directors, officers and household members of Unity One Credit Union are not eligible to participate in the sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding, in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 2. <u>How to Enter:</u> Eligible Unity One Credit Union members who book a new or used auto loan, or switch their current auto loan from another financial institution to Unity One Credit Union, during the promotional period are automatically entered into the Sweepstakes. Cancelled, denied, indirect and pre-existing Unity One Credit Union auto loans are not eligible. Limit one (1) entry per closed and funded loan during the Sweepstakes period. Odds of winning depend on the number of eligible entries received. Anyone age 18+ who does not qualify for the drawing by funding an auto loan during the promotional period can enter by sending a 3x5 postcard with their name, address and telephone number to Unity One Credit Union, Attn: Marketing Department, 6701 Burlington Blvd., Fort Worth, TX 76131. Must be postmarked by November 16, 2019, to be entered into drawing. One postcard per individual allowed.
- 3. <u>Sweepstakes Period:</u> The Sweepstakes begins on September 3, 2019, from 12:01 a.m. Central Time ("CT") and ends November 16, 2019, at 11:59 p.m. CT.



- 4. <u>Random Drawing/Winner Notifications:</u> One (1) Grand Prize winner will be selected via a random drawing conducted by Unity One Credit Union on or around November 26, 2019, from among all eligible entries received. Decisions of Unity One Credit Union are final and binding. The Grand Prize winner will be notified by Unity One Credit Union via email or telephone on or about the day of the random drawing. Failure to respond to the winner notification within three (3) business days will be deemed forfeiture of the Grand Prize and an alternate winner may be selected at Unity One Credit Union's sole discretion. Unity One Credit Union is not responsible for email notifications that are undeliverable or voicemail messages not received. Winner must have a valid Social Security Number, current U.S.-issued driver's license and a U.S. Government photo identification on file to be eligible to win.
- 5. Prizes and Approximate Retail Values ("ARVs"): One (1) Grand Prize One member will have his/her Unity One Credit Union auto loan interest reduced to 0% APR (up to \$3,000.00) for the remaining life of their Unity One loan on the specified vehicle. Any interest paid on the loan prior to the drawing will be reimbursed by Unity One Credit Union (up to \$3,000.00.) Winner will be required to sign an addendum acknowledging the change in APR and/or monthly payment. Any portion of the prize not accepted by the winner will be forfeited. Federal, state, and local taxes on the prize and any expenses relating to the acceptance and use of a prize not specified herein as being awarded are the responsibility of the winner. Interest charges over \$3,000.00 to be paid by member. Prize consists of only those items specifically listed as part of the Prize. The prize has no cash value and cannot be substituted by any winner, but Unity One Credit Union may substitute the prize, or any portion thereof, for a prize of equal or greater value at their sole discretion for any reason. The prizes are non-assignable and nontransferable and are not redeemable for cash. The Winner must meet the eligibility requirements as set forth in Paragraph 1 of these Official Rules. Winner is responsible for paying all applicable income taxes associated with accepting their Prize. Winner may be required to sign a liability and/or publicity release ("Prize Release") prior to issuance of a prize. Winner agrees to use of winner's full name and/or likeness for the purpose of appearing in print and/or electronic media for Unity One Credit Union without compensation. Unity One Credit Union may report the value of the prize to the IRS as required by law.
- 6. <u>Claiming the Prize:</u> Upon winner verification, as a condition of being named the official winner, the potential winner must claim his/her prize in person at a Unity One Credit Union location within 10 days of being named the winner. This is to verify that the prize is being given to the qualified winner and sign necessary loan addendum paperwork. Failure to comply with any deadline set forth in these



Official Rules shall be deemed to be the winner's forfeiture of his or her right to claim a prize. If winner cannot prove he/she is a qualified winner, the prize will not be awarded. Any unclaimed prize remains the property of Unity One Credit Union.

- 7. Participation Conditions/Release/Consent to use Likeness: By participating, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of Unity One Credit Union which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties from and against any and all claims, expenses, and liability, including, but not limited to, negligence and damages of any kind to persons and property, including, but not limited to, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's participation in this Sweepstakes, and acceptance or use or misuse of prize; (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or misuse of prize; and (d) allow Sponsor's use for promotional purposes of his/her likeness, voice and/or address (city/state) without any additional compensation.
- 8. General Conditions: Unity One Credit Union reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason whatsoever, including, without limitation, fire, flood, natural or man-made epidemic of health or other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Unity One Credit Union's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Unity One Credit Union in its sole discretion. Unity One Credit Union reserves the right, in its sole discretion, to disgualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Only the type and quantity of prizes described in these



Official Rules will be awarded. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Unity One Credit Union's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

- 9. Limitations of Liability: The Released Parties as set forth above are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited, to malfunctions, interruptions or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the participation process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of phone calls; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any Prize.
- 10. <u>Privacy Policies and Data Collection</u>: Information provided by you for this Sweepstakes on the entry form is subject to Unity One Credit Union's privacy policy located at <u>www.unityone.org</u>. By entering this Sweepstakes, each entrant agrees that the Unity One Credit Union has the right to contact the entrant by phone, direct message, or email accounts provided on the entry form to administer and fulfill this Sweepstakes.
- 11. Disputes/Governing Law: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or the prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate federal or state court; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' or legal fees; and (3) unless otherwise prohibited, under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with this Sweepstakes shall be governed by, and



construed in accordance with, the laws of the U.S. Government, without giving effect to any choice of law or conflict of law rules (whether of State, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the United States.
